Lady Amritbai Daga College for Women of Arts, Commerce & Science and Smt. Ratnidevi Purohit College of Home Science and Home Science Technology is a premier Women's College in Central India in existence for the last 93 years with its goal centered around women's progress in educational, social and cultural fields. It was established at a time when a women's college was considered a path breaking venture. The beginnings were humble.

On April 21, 1932 a citizens meeting was convened in which 'Women's Education Society' was formed with Rao Bahadur M.B. Kinkhede as its Founder President, Shri Y.M. Pathak as Founder Secretary and Smt. Ramabai Tambe as the first Principal of the college. The Constitution of the Society was drawn up by Justice W.R.Puranik and Shri T. J. Kedar. Sir Sorabji Mehta was the founder Chairman of the Executive Committee of the society.

The college was formally inaugurated by Honorable Justice Dr. M.B.Niyogi, C.I.E., the then Vice Chancellor of Nagpur University and later the President of Women's Education Society on 11th July 1932. The college was affiliated to the Nagpur University on 1st July 1935 as "Central College for Women" with Miss Shanti Rangarao as

the Principal and Lady Gowan (Wife of His Excellency, the then Governor of Central Provinces and Berar, Sir Hyde Clarendon Gowan) as President. The institution owes its present status to the illustrious and equally commendable dedication of luminaries who left their mark in the annals of the college. They were besides Rao Bahadur, M.B.Kinkhede and Lady Gowan, Lady Kalhum Wylie (wife of His Excellency, Governor of Central Provinces & Berar, Sir Francis Verner Wylie), Lady Muriel Twynam, (wife of His Excellency, Governor of Central Provinces & Berar, Sir Henry Twynam), and Smt. A. Pakwasa (wife of His Excellency, Governor of Central Provinces & Berar, Sir Mangaldas Mancharam Pakwasa).

Among the earliest to be associated with the college were Khan Bahadur M.E.R. Malak, Mrs. Stent, the then Vice Chancellors of Nagpur University viz : Justice Dr. M.B. Niyogi (1932 to 1936), Dr. Sir Hari Singh Gaur (1936 to 1938), Mr. T.J. Kedar (1938 to 1941) and Hon Justice W.R. Puranik (1944 to 1947), Justice M. Hidayatullah, Justice Kaushalendra Rao, Justice S.P. Kotwal, Justice Y.S. Tambe, Shri S.H. Battliwala, Hon. Sir M.B.

Dadabhoy, Mrs. Macfadyen, Shri S.D. Saklatwala, Nawab Mir Mehdi Ali Khan, Lady Kusum Trivedi, Shri A.D. Mani (M.P.) At a later date Justice N.L. Abhyankar and Justice B.A. Masodkar to name a few were among the many other distinguished personalities.

Presently, the society has as its President a legal luminary and former Advocate General of Maharashtra, Adv. V.R. Manohar.

At the establishment stage the College was given financial support by the trustees of Late Sir Dorabji Tata of Bombay. His Excellency Sir Hyde C. Gowan, the then Governor of Central Provinces also gave financial help to the college and Lady Gowan donated books to the college Library. The college continued to be patronized by philanthropists. Among them His Exalted Excellency the Nizam of Hyderabad rendered generous support to the college in the form of endowments. It also received donations from Mr. Bhulabhai Desai for the development of the library.

The college known as "College of Arts for Women" from 1932 to 1935 and as "Central College for Women" from 1935, moved to its own building in 1942 on a sprawling campus of 26 acres of land donated by the Governor Central Provinces and Berar in 1940 at Seminary Hills.

In 1942, Sir Sarvapalli Radhakrishnan delivered his inaugural address at the opening ceremony of the Seminary Hills Building. In 1949, Sir C. Rajgopalachari inaugurated the first lecture room of the college building at Seminary Hills.

**FACILITIES :**

**1. Library (S. P.Gharpure Information Centre) :** There is a fully equipped computerized libraries with Internet facilities besides departmental Libraries. The main general library is located at Shankar nagar campus.

**Rules of the Library:**

- i) All bonafide students are eligible to use the library.
- ii) Every student gets borrowers card on payment of Rs. 15/- If the card is lost, the student is required to inform the matter in writing to the Librarian immediately. Upon loss/damage of library card, a duplicate may be issued on payment of Rs. 20/-.
- iii) Immediately on issue of the book, every student should check the book thoroughly. Any mutilation or missing pages should be shown to the issuing clerk, and note regarding this should be taken. While returning the book, if it is found torn or mutilated, the student will be held responsible for that and she will have to replace the book or pay the amount of the book.
- iv) If the book is not returned within the due date, a fine at the rate of Rs. 1/- per day is charged.
- v) If the book is lost, the student has to replace the book or has to pay the cost of the book.
- vi) Students are not allowed to carry any belongings inside the reading room and have to show identity card to the Library Staff. Absolute silence is required to be maintained in the reading room.

- vii) The Library staff is empowered to check anything which students intend to take outside the Library.
- viii) Latest passport size photograph is to be affixed on the Library Card. The photograph should be same as that affixed on the identity card.

**2. Photocopying Facility :** Photocopying Facility is available for students & teachers on payment basis: 'Pratikruti Xerographic copying center' at Shankar Nagar College Library.

**3. Sports and Recreation :** The extensive ground on the campus provides ample scope for athletics and outdoor games. Provision is made for the following indoor and outdoor games: Table Tennis, Carrom, Badminton, Tenniquet, Volleyball, Throw/ball, Hockey, Kho-Kho and Basketball. Students-seeking admission under sports quota must take part in sports activities. The college also enjoys the honour of having many State and National players in different games.

The College participates in School, District, Divisional & State level sports and has been represented regularly in National and State Tournaments winning many kudos. The Physical Education Department has a facility of a Basketball Tar Court fitted with flood lights provided by Western Coalfields Ltd. to facilitate playing in the evening.

**4. L.A.D's Saraswati Kanya Sangh :** This basketball club exclusively for girls was established way back in 1988-89.

Since then students not only of L.A.D. College but of the vicinity are trained in the club through a well trained coach.

Summer coaching camps are also held every year and members of the club participate in every local, district, state and national level competitions. LA.D.'s basketball team has retained the University championship since more than two decades. Students desirous of joining the club may contact H.O.D., Physical Education Department.

5. **N.C.C.** : The National Cadet Corps, one of the oldest units, established in 1949 provides training and opportunities for N.C.C. Training. N.C.C. gives girl students basic knowledge about the defence of the country. Camps and courses in N.C.C. facilitates an all-round development for keen and sincere participants. ## OTHER INFORMATION

1. At the time of submission of any type of concession form students are required to produce their Identity Card, without which the form will not be accepted
2. Students belonging SC/ST/VJ/NT/SBC/OBC Category will submit GOI Scholarship or Freeship form only,
3. Students of outside Maharashtra State are not eligible to avail any type of concession.
4. Eligible & deserving students for the scholarship are advised to submit the prescribed application forms along with necessary certificates duly filled in to the Scholarship clerk on or before the dates mentioned. After this date, forms will not be accepted.
5. All scholarships payable to the students are directly deposited in their Aadhar link bank account by the Government.
6. All Concession holders must see the notices displayed on the college notice Board from time to time regarding the sanction of the scholarship forms etc.
7. All payments are made by transferring amount to students individual Aadhar link saving account, Therefore, all the students availing any type of concession are hereby advised to open saving account preferably in Bank of India or Bank of Maharashtra. Students are also advice to submit clean and neat photocopy of Bank Pass Book to Scholarship section along with mobile numbers, so that message regarding transfer of amount will be conveyed to them.

## ADMISSION RULES :

Application form and the college prospectus can be obtained from the college office on payment of prescribed Fees. Application for admission in any class / faculty should be registered as per the notification of the college given either in the newspapers or displayed on the college Notice Board. **The Degree College and Junior College shall reopen for the new session on Monday 16.6.2025.**

Students who have passed the qualifying examination from any Divisional Board or University other than Maharashtra State Secondary Education Board who wants admission to XI class must submit their migration certificate and all other required certificates in original. Junior College students who come from outside Maharashtra should bring eligibility certificate from the Maharashtra State Secondary Education Board, Nagpur. Otherwise their forms for admission to Junior College will not be accepted.

## ATTENDANCE:

practical's) in each of their subjects of study offered. Students are required to fill in the undertaking at the time of admission in the prescribed form as under. Students enrolled in N.C.C. or RT. classes must put in 75% attendance and attend all camps in N.C.C. also.

### REFUND OF DEPOSITS AND OTHER DUES :

Students should take back their deposits/ dues, if any, on submission of original receipt of the same within a year after their leaving the college. Students will have to apply for refund between

6. It is compulsory for the students to purchase the practical note books provided by the college.
7. Every student is expected to see the Notice Boards daily. It will be presumed that the notices displayed on the Notice Boards are seen and read by the student.

### COLLEGE EXAMINATION :

No student shall remain absent from any class test or college examination without special permission. The application requesting leave on medical ground specially at the time of the college examination will be treated as invalid if not accompanied by Medical Certificate.

A student who remains absent for both college test and examination in a year or has habitually missed class tests, will on no account be promoted to the next class or be permitted by the college to appear in the board exam. A strict record of marks is maintained by the college of all written work.

## RULES OF PROMOTION FOR FIRST YEAR JUNIOR COLLEGE STUDENTS.

- Tutorial/Seminar/MCQ,/Unit test etc. in the 1st term of 25 Marks,
- First terminal Examination- 50 Marks

- Second term Examination – at the end of second term of 100 Marks.
- Final results shall be decided on the Average marks of all the above exams.

which should not be less than 35 %.

- There shall be no re-examination for students who fail in the first year Junior college examination.
- Failures will not be promoted to higher class.
- Unfair means students indulging in unfair means shall be detain rusticated even if they obtain overall pass marks.

**NOTE-** Students of first year Junior college must appear in all Exams, Monthly tests, Unit tests, assignments, practical exams, 1st terminal exam and Annual promotion exam as the overall result is based on the average performance. The college authorities will not be responsible if the students are declared fail either due to poor performance or absence in the above exams.

## RULES OF CONDUCT FOR STUDENTS :

1. **UNIFORMS:** It is compulsory for all the students of the Junior college (XI & XII) of all streams to attend college in the Uniform approved by the college.

2. Students should not carry mobile phones in the college premises.
3. Students remaining absent for long period due to illness / mishaps in the family are expected to submit Medical Certificate / letters from parents / guardians immediately on joining. Submitting the same at the end of the year shall not be entertained.
4. Students shall be expected to attend minimum 75% theory and practical classes. Students should not remain absent without seeking prior permission for the respective teachers. Rs. 25/- per paper will be fined on remaining absent for college examination. **Students having less than 75% attendance will be detained and will not be allowed to take Board/ University Examination.**
5. Students shall be expected to obey all the orders and behave respectfully towards their respective lecturers, other teaching and non-teaching staff of the college. Students are expected to be punctual and fully responsive in the class.
6. Students shall not be allowed to join any other course of study simultaneously outside the college -- full time/ part time jobs / tuition classes etc. clashing with college timings.
7. No student shall attend classes other than her own or bring in the college premises any friend who is not a student of this college.
8. Off periods may be spent in library reading room/ students common room. Students shall not unnecessarily loiter in the college premises or sit/ stand in the corridors or sit on the parapet walls.

11. **Playing Holi in the college and hostel premises is strictly prohibited.**
12. Students shall use the college furniture, fans, books or any other college property with utmost care. The cost of damage done shall be recovered from the students individually or collectively as the case may be.
13. No student shall directly send anything concerning the college for publication either to the press or elsewhere without the prior approval or necessary permission from the college Principal. Any breach of this rule may entail outright expulsion of the student from the college.
14. Students are not authorized to form unions or societies in the college without the prior consent of the Principal. They shall also not invite guests or arrange lectures/ programmes without prior permission of the Principal.

20. Students shall be expected to keep their bi-cycles, two wheelers at the space provided properly locked. No complaints regarding loss of cycles kept unlocked or not kept at the space provided shall be entertained.
21. Only special notice shall be read out in classrooms, students are therefore, expected to see the notices put up on Notice Boards from time to time.
